Arrival & Dismissal Procedures <ul style="list-style-type: none"> All car riders will enter via Rolling Road and be dropped off in the cafeteria parking lot. Please reference the map that was emailed on August 25th. Only busses and some faculty vehicles will be allowed to enter the campus via Bloomsbury Ave. This will ensure that car riders and bus riders are in separate parts of the building prior to the beginning of period 1 and assist with distancing. 	Screening & Testing (<i>Safety is Our True North</i>) <ul style="list-style-type: none"> All families should screen students for symptoms prior to leaving home. Please use this checklist to determine if a student should or should not go to school. Persons with COVID-19 symptoms in school will be required to be tested or will be placed on quarantine, in alignment with guidance from the Maryland Department of Health.
Face Covering (<i>Safety is Our True North</i>) Requirements: All persons, regardless of vaccination status, must wear a face covering while inside a school. Exceptions to this requirement are: <ul style="list-style-type: none"> The person is alone in a private space. The person is eating or drinking. The person has a documented physical or developmental disability that makes wearing a mask unsafe. The person is under the age of two. The person is a student athlete engaged in the sport in the field of play. 	Social Distancing (<i>Safety is Our True North</i>) Requirements: Physical distancing of students from each other and between students and adults will be provided to the greatest extent possible, considering school enrollment and facility constraints. Strategies include: <ul style="list-style-type: none"> Use of classroom and cafeteria configurations that provide maximal separation between students. Restriction of field trips to day trips only, with plans to reduce exposure to large crowds.
Hand Hygiene (<i>Safety is Our True North</i>) Requirements: Employees and students have been instructed to adhere to best practices in hand hygiene and respiratory etiquette. Times for handwashing or use of hand sanitizer to include before and after meals, upon arrival to schools' offices and home, before and after use of any shared items, after use of the restroom, after sneezing/coughing and other time hands are contaminated.	Breakfast & Lunch <ul style="list-style-type: none"> Students will be required to scan a QR code on their cafeteria table and enter their name, table number, and lunch shift each day so that we may accurately take attendance and have a record of each student's location in the cafeteria. We will be opening the outside patio for all lunch shifts. 
Supplies & Devices: <ul style="list-style-type: none"> All service tickets are being processed by our three Tech Liaisons as we receive them from the Help Desk at The Department of Instructional Technology Incoming 9th graders without a student device will receive their devices the first week of school. 	Visitors (<i>Safety is Our True North</i>) <ul style="list-style-type: none"> To visit a BCPS school, visitors must have an appointment. Visits will be conducted remotely or outside, whenever possible. If an indoor visit is required, visitors will be required to wear a face coverings and practice social distancing.
